4. Postal/Courier fees to be paid by applicant or the ship owner/manager, along with the Application fee before the Certificate is issued.
5. This Application – along with clear and legibly scanned supporting documents as required – may be sent by email. Photographs must be of good quality, passport size and in jpg, bmp or similar graphics format.
6. Crew on board warships, fishing vessels, pleasure yachts not engaged in trade, or wooden ships of primitive build (STCW Convention Art. III) and all ratings are exempt from completing this Application
7. **Please note that the fee for processing this Application is USD\$500.00 or Euro 300 per Certificate of Competence plus Postage or Courier fees.**

The total Application fee must be received by Maritime Cook Islands before the Application can be processed.

Payment of the fee does not guarantee a successful Application.
